Rules for Commercial Vendors

General Rules and Regulations

1. All booths **must** be completed and exhibits in place by 6:00 p.m. on Wednesday. Set-up will be Wednesday 3:00-5:45 p.m. Tear-down is Saturday 8:00-11:00 p.m. Anything left in the building after 11:00 p.m. on Saturday will become property of the Tony's Pizza Events Center.
2. GPM Convention Hall will be open to the public and booths **must** be in operation the following hours:
Wednesday 6:00-9:00 p.m. Thursday & Friday 2:00-9:00 p.m. Saturday 10:00 a.m. to 8:00 p.m.
3. Exhibitors are not permitted to install machinery that might be objectionable in sound or endanger the safety of patrons. The use of public address, amplifiers, or other attention devices or systems by exhibitors will not be permitted without the permission of the Fair Board. Any system permitted must be operated at a moderate volume so as not to create annoyances to other exhibitors. Exhibitors will keep their exhibits, equipment, and demonstrations within their defined booth area. No demonstrations or soliciting in the aisle.
4. The Saline County Fair Association TRI-RIVERS FAIR is not liable for loss or damage to any exhibit.
5. No beer or other alcoholic beverages will be sold or dispensed in any way. No matches or peanuts/seeds/etc. in the shell shall be given out by exhibitors.
6. Any electrical needs other than the existing outlets will be charged to the exhibitor. Exhibitors must provide their own extension cords, etc.
7. NO REFUNDS WILL BE MADE AFTER JULY 1st.

Special Rules Rules and Regulations for Commercial Booths in GPM Convention Hall

1. The charges for rental space in GPM Convention Hall will be \$75.00 for one space, \$125.00 for two spaces, \$162.50 for three spaces, and \$200.00 for four spaces.
2. Booth spaces in GPM Convention Hall are 10' wide x 8' deep. Each booth will be provided with a back drapery, one 6' table with skirting and top, two chairs, vendor name card, and booth number. In accordance with our decorator's policy, exhibitors may not pin, staple, or tape anything to the drapery defining the booth space. Posters and signs suspended from pipe may not exceed five (5) lbs. in weight.
3. All exhibits in GPM Convention Hall are limited to a height of 8', unless otherwise approved by the Fair Board. Sides may carry background height to within 2' of front line of booth. The front 2' of space may not have any equipment or display over 42" high.
4. No food or opened drink will be sold or given away with the exception of your product.

Special Rules Rules and Regulations for Outside Commercial Booths

1. Outside commercial booth space will be \$75.00. These spaces are 8' deep x 16' wide and are located on the same parking lot as the carnival.
2. Exhibitors must provide extension cords, etc. and are responsible for their own security.
