The undersigned hereby agrees to be a Concessionaire at the Tri-Rivers Fair from Wednesday, August 3rd through Sunday, August 7th, 2022. It is agreed that compliance with the rules and regulations will be observed, and that a deposit of \$125.00 will be remitted with this contract by April 15th. No refund of payment will be made unless Concessionaire gives written notice of cancellation prior to June 1st. The Fair reserves the right to cancel this contract without comment by giving written notice of such action before July 1st. The Fair reserves the right to cancel this contract, with due cause, by giving written notice of such action and cause at any time.

Special Rules and Regulations

1. The charge to operate a concession stand at the Fair will be \$125.00 per space or 15% of the gross receipts (less applicable sales tax), whichever is greater. The \$125.00 deposit prepaid with this contract will be credited to the 15% payment. Concessionaire will submit a report of daily gross receipts at the end of the Fair on forms furnished by the Fair.
2. Concessionaire must comply with all City, County, and State health and/or business regulations.
3. Concessionaire will furnish copies of inspection licenses, sales tax permits, and a certificate of insurance from Concessionaire's general liability insurance carrier showing the Saline County Fair Association, Inc. d.b.a. TRI-RIVERS FAIR as additional insured for the period of August 3rd through August 7th, 2022 before this contract will be accepted.
4. Concessionaire will keep assigned area(s) free of trash and debris. The Fair will provide trash containers.
5. Concessionaires providing regular food will be open from (at least) 11:00 a.m. to 1:00 p.m. and 4:00-10:00 p.m. Those serving desserts (snow cones, funnel cakes, etc.) *only* will be open from (at least) 4:00-10:00 p.m.
